She has been recognized as a Charter Member of the “Eloise R. Lewis Legacy Society” on the School of Nursing’s 50th Anniversary in 2017 by establishing the Tomika Williams Scholarship. Prior to his retirement from the North Carolina Community College System (NCCCS) in 2012 after thirty-two years in state and local government, Kennon Briggs served for four and a half years as Executive Vice President and Chief of Staff, and for over a decade as Vice President for Finance and Chief Financial Officer for the System. Before coming to the NCCCS, Mr. Briggs had been a Senior Budget Analyst in the North Carolina Office of State Budget and Management for eleven years, with fiscal, policy and oversight responsibility for community colleges and the University of North Carolina System. Wheatley, DNP, RN, CENP, is President of [Wake Forest Baptist Medical Center](#) in Winston-Salem, N.C., and System Chief Nurse Executive and Senior Vice President of Clinical Operations for Wake Forest Baptist Health (WFBH). Dr. Wheatley joined WFBH in September of 2014 as Chief Nurse Executive and was promoted to President of the Winston-Salem campuses in April 2019.

In her role, she is responsible for the overall performance of health system operations on the Winston-Salem campuses, inclusive of Brenner Children’s Hospital, and for oversight of nursing practice throughout the health system. Dr. Wheatley has extensive experience as a healthcare executive, both nationally and internationally. Prior to joining WFBH, she served as the first Corporate Nurse Executive of SEHA, Abu Dhabi Health Services, in the United Arab Emirates. While there, Dr. Wheatley was responsible for the professional practice and development of more than 9,000 Nursing and Allied Health professionals and for the coordination of care in the advancement of patient outcomes throughout SEHA’s 12 hospitals and 62 ambulatory care clinics. Dr. Wheatley previously held senior leadership positions at Dekalb Regional Health System in Atlanta, Ga., serving in various roles including Senior Vice President, Chief Clinical Operating Officer, Chief Nurse Executive, and Chief Quality Officer.

Dr. Wheatley earned bachelor’s and Master’s degrees in Nursing at Georgia State University and her Doctorate in Nursing Practice at the University of Central Florida. She is Board Certified with the American Organization of Nurse Executives as a Certified Executive in Nursing Practice and has completed the University of Pennsylvania, Wharton School of Business, Nurse Leader Program. She has professional affiliations with the American Nurses Association, N.C. Nurses Association, Sigma Theta Tau International Honor Society of Nursing, American Organization of Nurse Executives, N.C. Organization of Nurse Leaders, American College of Healthcare Executives, and the Healthcare Information and Management Systems Society.

Dr. Wheatley is a Board Member of the Friends of the National Institute of Nursing Research (FNINR) and a CNO Council member for both the Beryl Institute and the HealthLeaders CNO Exchange. Dr. Wheatley serves on the advisory boards of several schools of nursing including Capella University, the University of North Carolina – Greensboro, and Winston-Salem State University. Her philanthropic interests include the economic independence of women in developing countries and educational preparatory programs with a global focus. She is a current sponsor of Women for Women International and a past member of the Board of Trustees of the Atlanta International School

Bridgett Byrd Sellars '95 BSN, '09 MSN, PhD, RN, CNE, FACHE, NE-BC

Bridgett serves on the Alumni Board of the School of Nursing She is the CEO of Dr Sellars Educate. Prior to that she served as the Clinical Director of AMN Healthcare and was a staff nurse then a senior nurse leader in an acute care environment. Dr Sellars was an assistant Professor at California State University.

Alisa Starbuck, DNP, APRN, NNP-BC, NEA-BC completed her doctorate of nursing practice at East Carolina University, earned a master of science in nursing from the University of North Carolina at Greensboro, where she also received her BSN. She completed a neonatal nurse practitioner certificate from Georgetown University.

Starbuck joined Wake Forest Baptist Health in 1986 as a staff nurse in the Neonatal Intensive Care Unit. Since then, she has served in numerous roles including transport team nurse, nurse educator, neonatal nurse practitioner and practitioner coordinator, manager of professional practice and director of pediatric critical care within Brenner Children's Hospital. In 2014, she transitioned to serve as director of advanced practice nursing, quality, research, and magnet. She led the nursing division to a successful fourth magnet designation in 2015.

Prior to her current position, Starbuck served as the chief nursing officer for the Winston-Salem campus. She has also overseen numerous successful clinical program site visits including the inaugural verification of the Pediatric Trauma Center, which marked the first program in the state verified by the American College of Surgeons.

As the vice president, Women's and Children's Health Services and executive director of Brenner Children's Hospital, she is responsible for strategies, facilities, operations, and quality of care for all women's and children's related patient care services at Wake Forest Baptist Medical Center, its affiliates, and outreach sites. Her responsibilities include developing and implementing a plan to attract key talent, including physicians, advanced practice providers and nursing to meet the workforce needs for clinical services. She is also responsible for organizing the clinical services into well-defined multidisciplinary care units focused around major areas of care and leading the institutional planning for development of new women's and children's care sites. Starbuck also works with affiliates and partners to optimize population health and move toward value-based care.
