FAC-3 2023-2025 Annual Service Agreement (Open-Ended) Contracts

Background Information

At the December 6, 2013, meeting of the Board of Trustees, the Board authorized the Chancellor, ex-officio, to appoint architects and engineers for projects with authorized funding of \$2,000,000 or less and authorized the Chancellor to report all such appointments to the Board at its next meeting.

A solicitation for professional services was advertised on UNC System Office website on November 1, 2022, and ninety-four (94) letters of interest were received for the ten (10) disciplines listed in the attached memorandum.

The pre-selection committee reviewed the letters of interest and based their selection on the firms' qualifications. The attached memorandum lists the firms recommended for projects with \$500,000 or less funding on an as-needed basis.

Based on the above information, the Chancellor appointed the selected firms on February 15, 2023.
